# **Botswana**

Visa is required for Canadian citizens to enter Botswana. Bayee Travel can assist you with your application to the Consulate for Tourist and business visa. Please fill in the Embassy application form below and return it back to us with your original passport, completed visa application form, recent photo, payment and other required supporting document. It is vital that all of the questions in the forms are answered.

#### **Tourist Visa Requirements**

- A valid passport (valid for at least 6 months from the date of entry, passport should have at least 3 empty pages)
- Two completed application forms, both in original handwriting.
- Two recent passport-size photographs, please append your signature on the back of each photograph and staple on photo to each application form.
- Copy of Landed Immigrant Certificate/Student visa (which ever is applicable)
- Copy of return air ticket.
- Copy of traveller cheques or letter from company indicating that they will take care of all expenses.
- Copy of Use of a Representative (IMM5476E). Sign item 10.
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways

# **Business Visa Requirements**

- A valid passport (valid for at least 6 months from the date of entry, passport should have at least 3 empty pages).
- Two completed application forms, both in original handwriting.
- Two recent passport-size photographs, please append your signature on the back of each photograph and staple on photo to each application form.
- Copy of Landed Immigrant Certificate/Student visa (which ever is applicable).
- Copy of return air ticket.
- Business invitation letter and a letter from company indicating that they will take care of all expenses.
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways
