

## Brazil

**Visa is required for Canadian citizens to enter Brazil.** Bayee Travel can assist you with your application to the Consulate for Tourist and business visa. Generally speaking, your first entry must be within 90 days from issuing date, and visa validity varies from 3 months to 5 consecutive years depending on visa officer's decision.

### Tourist Visa Requirements

- Passport valid for a minimum of 6 (six) months from date of intended arrival in Brazil.
- One (1) visa application form (<https://scedv.serpro.gov.br/frscedv/index.jsp>), duly filled online & printed out and signed by each applicant.
- One passport-type photograph, recently taken.
- Photocopy round trip ticket to Brazil, with flight numbers, dates and itinerary. In lieu of the ticket the Consulate will also accept a signed letter from the carrier or travel agent, on company letterhead, with the name of the vessel, itinerary, dates of arrival and departure, in and from Brazil.
- All document should be submitted within application expire date.
- Airline employees or standbys with open tickets must present copies ticket with itinerary and an airline ID card, or a signed letter from the airline on company letterhead, with the name of the employee and his/her itinerary.
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways.

### Business Visa (General meetings with business contacts including participation in a trade/industrial show) Requirements

- Passport valid for a minimum of 6 (six) months from date of intended departure from Brazil.
- One (1) visa application form (<https://scedv.serpro.gov.br/frscedv/index.jsp>), duly filled online & printed out and signed by each applicant.
- One passport-type photograph, recently taken.
- Photocopy of round trip ticket to Brazil or ticket in transit, with flight numbers, dates and itinerary. In lieu of the ticket the Consulate will also accept a signed letter from the carrier or travel agent, on company letterhead, with the name of the vessel, itinerary, dates of arrival and departure, in and from Brazil.
- One letter on company letterhead, addressed to the Consulate, signed by an authorized representative (other than the candidate for the visa), detailing the purpose of the trip to Brazil, itinerary, business contacts information, dates of arrival and departure to and from Brazil. The letter should also state that the company assumes all financial responsibility for the applicant while in Brazil. If the letter is signed by the business's owner, it must be notarized. **NO TECHNICAL ASSISTANCE INVOLVED DURING THE VISIT should be indicated on this letter.**
- All document should be submitted within application expire date.
- One business card with the applicant's name on it.
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways.

**In case of technical support or provision of services in Brazil, Work visa (for work & technical assistance) is required.**

- For the purpose of technical assistance (installer, trainer, technical support, etc.), please ask your local contact in Brazil to contact the Ministry of Labour ([www.mte.gov.br](http://www.mte.gov.br) – phone 5561 314 6417/6470), get a permit first before applying for work visa in Canada. **Our office doesn't provide work visa service.**
