Visa is required for Canadian citizens to enter Myanmar. Please fill in the Embassy application form below and return it back to us with your original passport, recent photo, payment and other required supporting document. It is vital that all of the questions in the forms are answered.

Tourist Visa Requirements (visa is valid for three months from issuing date with maximum 28 days stay)

- Original passport valid for at least six month with available blank pages for visa.
- One completed and signed application form plus 1 copy.
- 2 most recent colored photos (5x7cm) with white background.
- Travel arrangement confirmation/hotel or flight booking.
- A letter from your employer in the office letterhead specifying your job. If self employed, write a letter with details of your occupation. If retired, write a letter describing your job prior to retirement. For students, provide a letter from your school stating you are presently enrolled or a valid student's ID.
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways.

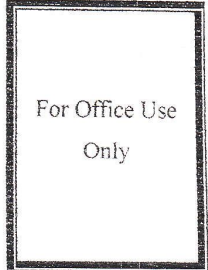
Please notice that the final decision on issuing a visa is at the total discretion of the designated Embassy.
