**Visa is required for Canadian citizens to enter Vietnam.** Please fill in the Embassy application form below and return it back to us with your original passport, recent photo, payment and other required supporting document. It is vital that all of the questions in the forms are answered.

**Tourist Visa Requirements**

- Original passport valid for at least six month & one photocopy of passport (the page with the picture)
- One completed and signed application form
- Two most recent passport sized photo
- Travel arrangement confirmation
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways

**Business Visa Requirements**

- Original passport valid for at least six month & one photocopy of passport (the page with the picture)
- One completed and signed application form
- Two most recent passport sized photo
- Travel arrangement confirmation
- Business visa approval obtained by his/her sponsor or business partner in Vietnam
- A pre-stamped or pre-paid return envelope. If the application is sent by **Canada Post**, a signature sticker is required on both ways

\*\*\*Validity on this visa is 1 month from your scheduled entry date, and you must enter into Vietnam within this validity.
