Visa is required for Canadian citizens to enter Zimbabwe. Bayee Travel can assist you with your application to the Consulate for Tourist visa. Please fill in the Embassy application form below and return it back to us with your original passport, completed visa application form, recent photo, payment and other required supporting document. It is vital that all of the questions in the forms are answered.

Tourist Visa Requirements

- Completed visa application which must be filled out using a ballpoint pen or typewriter (do not use red ink) - the applicant's signature is required. Please bear in mind, that the form is universal, questions not applicable to you leave blank. Please do not fold the application form
- Original passport valid for at least 6 months before its expiry date
- Two (2) recent passport size photos
- A round trip air ticket
- Sufficient funds for your stay
- Prepaid self-addressed envelope or prepaid waybill. If the application is sent by **Canada Post**, a signature sticker is required on both ways
